FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

During the early stages of the pandemic/1st lockdown, Police Scotland blocked off driver access to a number of areas; in relation to North Ayrshire, this involved beach access (i.e Stevenston beach was blocked off (Shore Road to Stevenston Point, just after Clark Crescent), Saltcoats Harbour etc).

Could Police Scotland please provide details of what permissions (legally, legislatively etc) they had/believed they had, allowing for closing off access to public areas for drivers.

For the avoidance of doubt, I'm looking for specific legislation that granted the Police powers to close off these areas (i.e were closures legal/illegal).

I can advise you that Police Scotland does not hold the information requested. In terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

By way of explanation, Ayrshire Division have advised that Police Scotland did not block off access in the Stevenston or Saltcoats areas (beaches, car parks or otherwise) apart from an operational decision due to an ongoing incident, which was not related to Covid-19.

North Ayrshire Council, in keeping with the approach taken by South and East Ayrshire Councils did close local authority car parks and toilets etc.

The matter was discussed at the weekly Covid-19 meetings with partners in North Ayrshire, including legal and a number of other departments from the local authority and Chief Inspector Shaw was fairly resolute that it required to be a council decision in terms of which closures they implemented. Similarly, when the areas were being opened up again the decision to do so lay with the local authority.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
