Your recent request for information is replicated below, together with our response.

Please treat every statement found in these documents as a question according to the Freedom of Information Act;

1a. Did the Coronation of Charles Windsor break numerous traditional rules

2a. Would Charles Windsor be only known as King by name

3a. Does Charles Windsor possess the title of King of the United Kingdom

4a. Is Camilla a legal and sovereign Queen

5a. Can Charles Windsor, legally pass on the title of King to an heir

4c. Would it be correct to say Coronavirus is a group name for the Common Cold, Flu and Pneumonia

5c. Did the official UK Government website class Covid-19 as low infection on March 19th 2020

1d. Did the UK Parliament officially declare Covid-19 as low contagion and not life threatening in June 2023

2d. Since June 2023 would Covid-19 vaccinations being administered to the UK public be classed as legal

3d. Have any UK Politicians profited from the so called Covid-19 pandemic

4d. Would it be correct to generalise Rishi Sunak's mother-in-law, is a major share holder connected with Covid-19 vaccinations

5d. Does the UK typically record approximately 18,000 fatalities annually due to the Common Cold, Flu, Pneumonia

1e. Did the UK record less than 777 fatalities in 2020 due to the Common Cold, Flu, Pneumonia

2e. How many UK fatalities were there recorded in 2020 due to Common Cold, Flu, Pneumonia

3e. Is it true Coronavirus is a natural cleansing mechanism for humans attempting to remove pathogens (infections)

4e. Are Humans typically in sync with the body processes of other individuals

5e. Could it be true to say the subconscious can trigger similar response phenomena with; yawning, laughing, smiling, tiredness, thirst, hunger, female menstrual cycles, walking in sync, crowd mentality, Common Cold activation etc.

1d. Can pathogens (infections) in the human body trigger the natural self cleansing process

I can advise that Police Scotland does not hold the above requested information.

In terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

By way of explanation, Police Scotland does not hold any of the above requested information.

1c. How many Covid-19 fatalities have there been recorded in servicing Scotland Police between 1st January 2020 and 2nd Mar 2024

Police Scotland don't hold any information regarding the cause of death, as such we would be unable to say whether someone has died due to COVID-19 or complications arising from the virus.

As you will be aware an individual's right in terms of the legislation is to obtain information held by a public authority at the time a request is received and there is no obligation on them to create new information specifically for such a request. Accordingly, in terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

To be of assistance I can advise, there has been 21 deaths in service during January 2020 to March 2024.

2d. Will anything asked or suggested in these FOI be treated as acts of treason

3d. Is it mandatory that a Police Constable swore an Oath to act impartially and protect the public

4d. Would it be correct to assume, one of the roles of the Chief Constable of the Scotland Police to share vital information locally, nationally and internationally

I can advise that Police Scotland does not hold information in the format requested.

In relation to Questions 2d, 3d, 4d, the information requested is seeking opinion, not recorded information, accordingly, in terms of Section 17 of the Act, this letter represents a formal notice that information is not held.
