FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

I would like to make a Freedom of Information request in relation to custody records and/or crime recording data please.

- 1. Specifically, I wanted to find the recorded nationality of those arrested and/or convicted in relation to the following crimes.
 - Theft from shop
 - Human trafficking
 - Modern slavery
 - Benefit fraud
 - Drug offending
 - Metal theft or the equivalent category.

In relation the nationality of those convicted, I can advise you that Police Scotland does not hold the information requested by you. In terms of Section 17 of the Act, this letter represents a formal notice that information is not held.

By way of explanation, the role of the police in Scotland, in relation to crimes and offences, is to investigate the circumstances and where sufficient evidence exists to then report the matter to the relevant Procurator Fiscal. It is a matter for the Procurator Fiscal to decide on and to progress any prosecution through the courts.

Most benefit fraud cases are dealt with by HMRC and do not always end up as arrests in police custody, however, there was 1 arrested person brought into custody in 2018 in relation to the following offence.

Drug offending

Drug offences are all charges where 'drug' is mentioned.

Metal theft or the equivalent category

In relation to metal theft, I regret to inform you that I am unable to provide you with the information you have requested, as it would prove too costly to do so within the context of the fee regulations. As you may be aware the current cost threshold is £600 and I estimate that it would cost well in excess of this amount to process your request. As such, and in terms of Section 16(4) of the Freedom of Information (Scotland) Act 2002 where Section 12(1) of the Act (Excessive Cost of Compliance) has been applied, this represents a refusal notice for the information sought.

By way of explanation, there is no specific charge for 'Metal theft' this would come under common law theft and it is not possible to differentiate, therefore,to obtain the information sought would require an individual to review all crime files for theft for the period requested. This would be a significant task and would exceed the cost threshold. To illustrate the extent of this task for recorded theft crimes for the second quarter 2021/22 alone there were 12,166 recorded crimes. If we estimate that it would take 5 minutes to review each file this would totally over a 1,000 hours and at a cost of £15 per hour this would exceed the time and cost threshold set by ministers.

If you are dissatisfied with the way in which Police Scotland has dealt with your request, you are entitled, in the first instance, to request a review of our actions and decisions.

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to foi@scotland.pnn.police.uk or by post to Information Management (Disclosure), Police Scotland, Clyde Gateway, 2 French Street, Dalmarnock, G40 4EH.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision. Should you wish to appeal against the Office of the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
